Abstract

Transgender individuals in India have historically faced discrimination, exclusion, and lack of legal protections. While progress has been made through legal reforms and awareness campaigns, societal acceptance remains a challenge. This study examines the evolving perceptions in Faridabad, highlighting struggles, progress, and the ongoing fight for inclusion and rights. This study is based on primary data, where a questionnaire was framed and responses were collected from 40 respondents. This study examines the transformation in community perceptions regarding the survival of transgender people in Faridabad, utilizing both primary and secondary data. By analyzing past research and surveying 50 participants, from whom only 40 responses were received through random sampling, we ensured unbiased insights. Descriptive statistics helped simplify data interpretation, offering a more precise understanding and valuable contributions to existing knowledge. Ensuring equal rights for transgender individuals requires inclusive policies in education, healthcare, and workplaces. Awareness programs should combat stigma, and governments must enforce anti-discrimination laws. Public support, gender-neutral spaces, and equal job opportunities can foster acceptance. A collective effort by society, government, and individuals can create a more inclusive and compassionate world for transgender people.

Introduction

Discrimination based on gender is an unjust practice. In India, there was a time when people of different genders, including men, women, and transgender individuals, were treated unequally. While rights have been granted to men and women, transgender people often face discrimination and harassment. In the past, they survived in society without the recognition or protection of their rights, making their existence difficult. However, over time, perceptions have started to change.

While society has been slow to accept the transgender category as a third gender, there is gradual progress, and acceptance is slowly emerging. (Alegría, 2018). including India. Historically, people of different gender identities- specifically men, women, and transgender individuals- were not treated equally. Transgender individuals have been subjected to minimization, often needing fundamental rights and opportunities available to others.

Over the years, significant steps have been taken to address gender inequality. For instance, the Indian government took exceptional steps to grant women equal rights, including access to education, freedom of speech, and protection under the law. (Huffaker & Kwon, 2016). Despite these advancements for women, the transgender community still faces numerous challenges in being recognized as equal members of society.

Transgender individuals continue to struggle with societal prohibition, discrimination, and harassment. (Day & Nicholls, 2021) For a long time, they had no legal protections and were forced to navigate life without the freedom afforded to other genders. As a result, their

The rules also include measures for non-discrimination in education and employment, as well as access to healthcare services and other welfare benefits. According to the 2011 Census, the 'other' category includes 4,87,803 people, which not only covers transgender individuals but also anyone who wants to identify their sex as 'other'.

Additionally, the study explores and provides insights into how these perceptions impact the social, economic, and psychological well-being transgender individuals, contributing to strategies for promoting unity and equity.

By examining the community's views on issues such as access to healthcare, employment opportunities, and legal protections, the research seeks to identify the barriers transgender individuals face in achieving full societal inclusion.

Furthermore, it will assess the role of education, media representation, and policy changes in shaping attitudes and fostering an environment of greater empathy and understanding. This study aims not only to shed light on the current state of transgender inclusion but also to propose actionable recommendations for improving the support system and creating a more inclusive society for all gender identities.

Scope Of Study

This study was conducted in the Faridabad area, focusing on understanding the community's perceptions regarding the survival of transgender individuals. The study is based on

The sample size, though relatively small offers insights into how local communities view issues surrounding transgender rights, recognition, and inclusion. Through this research, I aim to contribute to a better understanding of the social dynamics at play and highlight areas where further awareness and support might be needed. Additionally, the responses gathered will serve as a basis for concluding the overall attitudes transgender individuals within Faridabad, providing context to broader national or global trends.

Methodology

Our research methodology involved the utilization of both secondary and primary data to ensure a comprehensive analysis and strong findings. We began by reviewing existing research papers and analyzing their data. It allowed us to build a strong foundation for our study by understanding previous findings and including them in our framework. The secondary data provided valuable insights and served as a reference point to arrange our research objectives with existing knowledge.

For primary data collection, we designed and distributed a questionnaire. A total of 40 valid responses were received, forming the main dataset for our analysis. To ensure unbiased results, we employed a random sampling technique, allowing each participant an equal being of The collected data was anatomized using descri ptive statistical styles. This approach enabled us to effectively summarize and organize the data, simplifying the interpretation Descriptive statistics provide an overview of key trends, patterns, and characteristics of the dataset, which is critical for drawing meaningful conclusions.

Data Analysis & Interpretations:

In the data analysis, 74.4% of respondents are female, and 25.6% are male. Among these, 87.2% fall within the age group of 20-30 years, while the remaining participants are distributed across the age groups of 30-40, 40-50, and 50 and above. Additionally, 82.1% of respondents attained higher education qualifications,

highlighting a highly educated sample population.

When asked about familiarity with transgender individuals, 79.5% of participants reported being familiar with transgender individuals, while 20.5% were not. This suggests that a large majority of respondents have had some exposure or understanding of transgender people, which may influence their views and perceptions. In terms of interaction, 56.4% of respondents have interacted with transgender individuals, whereas 43.6% have not had such interactions, indicating a significant proportion of individuals have direct experience engaging with transgender people

Regarding perceptions of media portrayals of transgender individuals, 18.9% of respondents feel that the media portrays transgender people fairly and accurately. In contrast, 32.4% believe that the media portrays transgender individuals not fairly accurately, and 48.6% are unsure, revealing a mixed view of how transgender individuals are represented in the media. This uncertainty may suggest that many respondents might be lacking sufficient exposure to diverse media portravals or might be unaware of the nuances in such portrayals.

Finally, 79.5% of respondents indicated that their attitudes toward transgender individuals have become more positive over time, while 20.5% stated that their attitudes have remained the same. This shift toward more positive attitudes may reflect broader societal trends toward acceptance and awareness of transgender issues. It's also noteworthy that the percentage of individuals whose attitudes have remained the same is relatively small, which may suggest that attitudes are evolving in response to growing visibility and dialogue about transgender rights and inclusion.

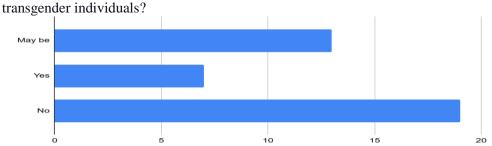

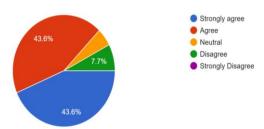
 Do you believe society provides enough resources to support transgander individuals?



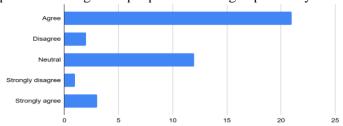
• In your opinion, do transgender people face significant challenges in society?



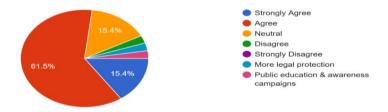
Do you believe transgender individuals should have the same rights & opportunities as others in society?



• Community perceptions of transgender people have changed positively in recent years.



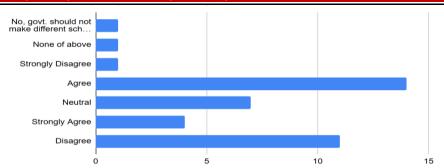
• People can better support equality and the smooth survival of transgender in the community.



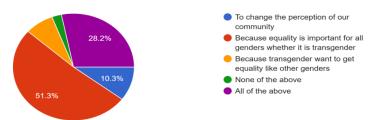
• The government has provided facilities & resources equally to the transgender.
