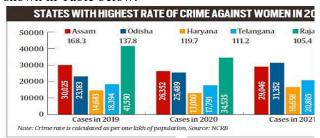

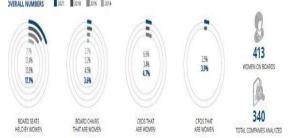
Objective 2: To analyze the role of women in the 21st century in India.
